Scope of Contest	<p>The competition requires the demonstration of a performance of an occupational skill accompanied by a clear explanation of the topic through the use of experiments, displays or practical operations.</p> <ul style="list-style-type: none">• An actual technical skill must be performed as opposed to an illustrated talk. The skill does not have to relate to the occupational program of the competitor.• Notecards and other reference materials are not permitted.• The demonstration shall be at least five minutes in length but shall not exceed seven minutes. Penalty: Five points will be deducted for each 30 seconds or fraction thereof under five minutes or for each 30 seconds or fraction thereof over seven minutes.• Time limit: Time will be started when the demonstration begins. The timekeeper will signal the speaker at five minutes, six minutes and six minutes 30 seconds.• Competitors will be allowed three minutes to set up the demonstration and three minutes to clear the demonstration room. Penalty: Five points will be deducted for each 30 seconds or fraction thereof over the three-minute allowance.• A performance space of 8'x12' will be provided that contains one table and one duplex (two plug-ins) 120-volt (15 amp) electrical outlet.• Any visual or auditory aids (signs, charts, transparencies, slides, diagrams, tapes, CDs) are to be prepared by competitors. Professionally prepared visuals and audio materials may not be used. No open flames, no combustible or hazardous chemical compounds, no fluids containing pathogens or toxic chemicals and no pressurized containers are allowed.• The competitor will not mention their name, school, city or state.• The demonstration is an individual performance. An assistant may be used to set up and dismantle the demonstration if it is very heavy or large. Otherwise, the competitor is responsible for setting up the demonstration. Models may be used in the demonstration but will not say or do anything that assists the demonstration other than serve as a model as needed. Example: facial, clothing design demonstration, etc.• Basic safety practices related to the skill performed must be followed. Safety violations will be subject to penalties of one to 10 points. Judges may interrupt the demonstration for serious violations.• The competitor may show the judges an item but may not physically hand a judge any item, including food sampling. <p>Please see judging rubric at end of document.</p>

Clothing	<p>Official Dress: Official SkillsUSA red blazer, white shirt, black pants or skirt, and black dress shoes. Black socks must be worn with pants and nylons must be worn with a skirt (either skin-tone or black). Males must wear a black tie.</p> <p>OR</p> <p>School Uniform appropriate to the contest: Professional attire worn in the classroom such as a criminal justice uniform, chef attire, health scrubs or cosmetology scrubs with all identifiers covered. This includes shoes.</p>
