Scope of	The technical skill performance tasks will a			
Contest	The technical skill performance tasks will assess skills in facial cleansing massage (15 minutes), basic facial (30 minutes), and beauty makeup application (60 minutes). Technique is scored in the performance tasks of facial massage, basic facial and beauty makeup application. An emphasis on safety and health will be used in all segments of the skill performance areas. Observations during each segment and evaluation of the finished product will be considered in the scoring.  • The competition rules will be reviewed at the orientation. At the orientation, the competitor will submit written theme in a plastic and 4"x 6" or larger full face BEFORE picture (printed) of model.  • All competitors must always keep their working area clean and organized.  • All competitors must follow sanitation and safety procedures throughout the competition.  • Competitors will prepare and perform an oral communication presentation. This will consist of a two- to three-minute oral presentation of an analysis of the skin and client consultation. Competitors will be given a skin type and should be able to recommend a skin care treatment and home care regimen.  • Penalty points can occur for the following:  • Leaving the competition area before completion of task (applies to both competitor and model) without proper escort.  • Any product used that is not as manufacturer intended.  • Any product that appears to have been altered or not properly identified with the manufacturer's original packaging and original labeling.  • Working after time is called.  • Cell phones or other forms of communication technology are not to be in the competition area. If models and/or competitors are using any digital communication device competitor and model is limited. Any form of communication device competitor and model is limited. Any form of communication with observers, judges and other competitors is prohibited during the competition and may be grounds for disqualification.  • All times are approximate and will be confirmed during orientation.

	<ul> <li>All necessary product applicators such as: spatulas, cotton swabs, fan and mask brushes, cotton 4x4 pads or sponges, tissues, mascara wands, makeup brushes. All applicators must be disposable or disinfected.</li> </ul>			
	• Eyelashes, adhesives, tweezers, scissors and necessary application tools with alcohol			
	wipes and sanitizers.			
	A minimum of six (6) white terry towels (no holes/stains)			
	A warmer will be provided.
