<b>Location</b>	Ohio State Beauty Academy 1760 N. Eastown Road Lima, Ohio 45807	<b>Contest Time</b>	Immediately Following Orientation (CLOSED contest)
<b>Scope of Contest</b>	A verbal communications test will assess competitors' verbal presentation skills. Separate performance tests assess skills in haircutting and styling (45 minutes), and long hair design (60 minutes): <ul style="list-style-type: none"><li>• The competition rules will be reviewed during orientation.</li><li>• All competitors must keep their work area clean and organized.</li><li>• All competitors must follow sanitation and safety procedures throughout the contest.</li><li>• Professional attitude and communication are expected throughout the contest.</li><li>• Once time is called, competitors must stop working. Touching the hair of the mannequin or model after time is called will result in three penalty points.</li><li>• Cell phones and other electronic devices must be turned off during the contest.</li><li>• All times are approximate and will be confirmed during orientation.</li></ul>

<b>Eligibility</b>	1 contestant for every 50 paid members enrolled in program		
<b>Clothing</b>	<ul style="list-style-type: none"><li>• School uniform appropriate to contest: professional attire worn in the classroom such as a criminal justice uniform, chef attire, health scrubs or cosmetology scrubs with all identifiers covered. This includes shoes.</li></ul>		
<b>Provided by Contestant</b>	<ul style="list-style-type: none"><li>• Professional Resume – must be typed and physically produced as a hard copy</li><li>• Emergency Medical Form (contestants must have this to compete)</li><li>• <b>**Mannequin heads will be provided at contest site.</b></li><li>• Writing utensil</li><li>• State board-approved disinfectant</li><li>• Hand sanitizer</li><li>• Blood spill kit</li><li>• Two manikin clamps</li><li>• Styling product(s) of choice</li><li>• Combs and brushes</li><li>• Bobby/hair pins</li><li>• Thermal tools (flat iron and/or curling iron)</li><li>• Shears and razor</li><li>• Hair clips</li><li>• Spray bottle (filled with water)</li></ul>		

<b>Contest Standards</b>	<ul style="list-style-type: none"> <li>• Blow dryer</li> </ul> <p><b>Contest Skilled Performance Standards</b></p> <p><b>CO 1.0</b> - Long Hair Design: Create a long hair design of your choice within a one-hour time period.</p> <p><b>CO 4.0</b> - Uniform layer haircut (90 degree haircut) Procedure: Create a uniform layer (90 degree) haircut and design with criteria selected by the national technical committee.
