State Officer Program 2024-2025

Purpose: To ensure that SkillsUSA Ohio has the best representation and quality officers possible to serve as ambassadors for the state organization, not only in local communities and schools, but on a State Level. In order for Ohio to have proper representation, it is necessary to ensure proper and prepared candidates to complete the year of service that is required by the officers. The program will provide a greater understanding of the organization for State Officers in order to expand their opportunities, duties, and responsibilities prior to conferences and provide a greater professional development opportunity in order for the State Officers to serve as ambassadors for the organization.

Expectations: State Officers are expected to be of the highest quality and should be in good academic standing prior to running for office. State Officers are expected to maintain grades greater than a "C" average and abide by the code of conduct at all times. Violation of either of these conditions will result in removal from office. State Officer Candidates need to achieve a minimum of an 80% on the officer exam, complete an application, essay, and enrollment packet complete with headshot photo by March 15, 2024. State Officers are expected to be active throughout the year; it is an on-going commitment. Officers should take this into consideration before applying to run for office. Officers may be selected for special responsibilities throughout the year based on merit. Throughout the year, officers will be responsible for serving as ambassadors for their regions and with their schools, making public relations contacts, and promoting the organization with the guidance of SkillsUSA Ohio. All officers will be responsible for providing a bi-monthly report to show their growth and outreach efforts.

MANDATORY EVENTS - Failure to complete any of these may result in removal from office.

*State Officer Retreat – June 10-14, 2024 – Receive training on becoming a state officer and other professional development opportunities, including interaction with business and industry partners. Assist in training National Voting Delegates and Candidates while learning how to lead the National Delegation in Atlanta, GA.

*Ohio National Prep Conference –June 7, 2024 - Meet National Voting delegates and learn responsibilities of National Conference

*National Conference—June TBD 2024 — Attend National Conference in Atlanta, GA, and serve as leaders for Ohio Delegation and National Officer Candidates. Select leadership opportunities may also be included during this conference.

***Summer Camp – TBD** --Perform all ceremonies at Summer Camp while providing training to students on various topics to be decided at State Officer Retreat. Serve as Assistant Group Leaders. Interact and serve as ambassadors with peers.

***Fall Retreat- (1 evening & 1-day October/November 2024 TBD)** - Preparation for fall leadership conference, presentation, and script work

***Fall Leadership Conference – November 9-10, 2024 –** Lead and facilitate fall conference including opening ceremony. Select Officers will be assigned presentations for students and advisors.

*Winter Retreat-November/December 2024 TBD - End of year wrap up and coming year planning *Goodwill Tour-Year Long/Selected Dates – Serve as student Ambassadors to visit different schools and business and industry partners in order to educate and promote SkillsUSA.

*State Conference Retreat- Feb/March 2025 TBD - Preparation for State Conference.

*State Conference (April, TBD 2025) Serve as courtesy corps, working with state staff and regional advisors to set up and maintain the conference Lead State Delegate Assembly, perform opening ceremony, and provide advance courtesy corps roles as assigned, elect, and install new team of officers.

*Regional Officer Training Institute (ROTI) – January TBD, 2025 – Regional Officer Training in Columbus. Serve as leaders and facilitators for training regional officers. Serve as ambassadors with National Office. Any officer that does not attend WLTI will be required to attend ROTI.

*SkillsUSA Board Meetings- October & February - 1 day report to SkillsUSA Ohio Board of Directors. *CTEP Meeting and Report-October & March - 1 day report to CTEP about SkillsUSA

***Washington Leadership Training Institute (WLTI)- September 2024 - Officers** will be given the opportunity to apply with State Director for a unique leadership experience provided by SkillsUSA National program.

*Regional Conferences – February/March 2025 – Work with Regional Advisors assigned to their region to perform Awards Ceremony and assist with making the conference a success.

Roles at all of these conferences and special invitations will be determined based on the assets, skills, and interests of each student; the goal is to ensure that all students get the most out of their regional officer experience while representing SkillsUSA Ohio to the best of their ability.

State Officer Election Process

State Officers will be elected at the High School State Delegate Assembly held at the SkillsUSA Ohio Championships. Officers will be elected as a "slate" – 7 officer positions are obtainable. Each school that has qualified voting delegates is eligible to submit one candidate for each office. Candidates must complete the screening process and be eligible to participate in the election.

State Officer Candidate Qualifications

- 1. Candidates must be an active high school SkillsUSA member for the current year by the SkillsUSA Ohio dues deadline.
- 2. Candidates must be enrolled in an approved Career-Technical program and participating in a SkillsUSA Chapter.
 - a. Students must have been active members within their chapter.
 - b. Must have participated in Fall Leadership Conference
 - c. Summer Leadership Conference is strongly recommended for candidates to have attended as Juniors.
- 3. Candidates may not have previously held or currently hold a state office.
- 4. Each campus is permitted to test as many potential candidates as they wish.
 - a. A maximum of 7 candidates may run from any single campus.
 - b. CANDIDATES MAY BE FRESHMEN, SOPHOMORES, or JUNIORS.
- 5. No Career-Technical Planning District can have the president elected two years in a row.
- 6. Candidates cannot be state voting delegates.
- 7. Candidates cannot compete in the state SkillsUSA Championships.
- 8. Candidates are not eligible to run for national office.
- 9. A maximum of seven officers will be elected, these officers will be elected as a slate of state officers, a President and Vice President will be chosen based on performance and merit following state officer retreat.

Procedure to run for state office

- I. The candidate must complete a State Officer Candidate Application.
- 2. An administrator/advisor must request screening test materials prior to the request cut-off date of March 15, 2024.
- 3. A school administrator/advisor must administer the screening test (student can take the test one time only).
 - a. Test will consist of 25 multiple-choice questions from leadership general knowledge, the SkillsUSA Framework, the SkillsUSA Career Essentials and/or the Leadership Handbook.
- 4. The candidate must score 80% or better to be placed on the primary ballot.
- 5. An administrator must return the qualified application to the SkillsUSA Ohio office March 15, 2024.
- 6. The candidate must attend the state conference delegate assembly, and:
 - a. Must be in Official SkillsUSA dress.
 - b. All Candidates will give speech of no more than 2 minutes in length.
 - c. The top 28 Candidates will appear on a primary ballot and will receive an impromptu question based around general leadership or SkillsUSA Knowledge.
 - d. The top 14 candidates will appear on the final ballot and will respond to a problematic oral question based on SkillsUSA knowledge and leadership.
 - e. In between each ballot a 5-10 minute meet the candidate caucus session willoccur.
 - f. Skits are not permitted.
 - g. Candidates may not use their own school names in their speech.
 - h. Candidates are not permitted to use other school names in their speech.
 - i. Candidates are not permitted to ask for audience participation during any response on stage.
 - j. Campaigning in any form or manner may not take place prior to the mandatory state officer candidate orientation meeting on Tuesday.
 - k. Campaign materials may only be displayed in designated Meet the Candidate area.
 - Materials that do not fit within the designated campaign space will not be permitted and are subject to disqualification (half of a 6 ft table). Materials must be a table top display-and cannot be posted on the wall or stand in front of or behind table.
 - m. State Candidates may participate in a meet the candidate session prior to election.
 - n. Campaign materials must not consist of anything that can be consumed by a person.
 - o. Campaigning on social media prior to the meet the candidate session is not permitted.

Ties

- 1. A tie for second place on the primary ballot will result in the candidate with the most votes (first place) and both second place candidates being on the final ballot.
- 2. A tie on the final ballot will be broken by the results of the preliminary ballot. If still tied, another impromptu question will be asked by the SkillsUSA Ohio state director or designated person, and the delegates will vote by secret ballot. This procedure will continue until the tie is broken.

2024 High School National Officer Candidate Program

Purpose: To ensure SkillsUSA Ohio has the best representation and quality officers possible to serve as ambassadors for the organization, not only in local communities and schools, but also on a national level. In order for Ohio to have proper representation at the National Level, it is important to ensure that Ohio is able to get two officers elected, and that these officers are of quality caliber and substance. The program will provide a greater understanding of the organization for National Officers in order to expand their opportunities, duties, and responsibilities prior to conferences and provide a greater professional development opportunity.

Expectations: Students running for National Office are expected to be of the highest quality and should be in good academic standing prior to running for office. National Officers will be expected to maintain grades greater than a "C" average and abide by the Code of Conduct at all times. Violation of either of these conditions may result in removal from office.

(To be turned in during Candidate Orientation prior to the State Delegate Assembly), as well as an application (complete with photograph), essay and enrollment packet by March 15. Each potential National Officer Candidate will have to complete an interview process with a team selected by the State Director. The outcome of the interview will determine the candidate's ability to run for one of the two spots before the State Delegation at the State Conference in April. Once the officer candidates have been selected to go onto Nationals by the State Delegation, they will be expected to attend delegate training which will take place in June. This will provide added training and knowledge the candidates to the best of their arrival at Nationals, while allowing the delegates to get to know the candidates will be expected to maintain an active role during the year after their election, even if they are not elected Nationally, based on merit and performance at Nationals. Throughout the year, officers will be responsible for serving as ambassadors for their regions and for their school, making public contacts and promoting the organization with the guidance of SkillsUSA Ohio. All officers will be responsible for providing a bi-monthly report to show their growth and outreach efforts.

*Getting elected to National Office does not guarantee the National Officer a spot on the State Officer Team; this will be based on merit of the officer.

*Assignments and conferences are determined by SkillsUSA and must be approved by the school and state association.

*Ohio National Prep Conference – June 7, 2024 - Meet National Voting delegates and learn responsibilities of National Conference

*National Leverage and Engage Training for Student Leaders and National Engage Training for Advisors- June TBD, 2024 -This training is mandatory for National Officer Candidates and their Advisors. This expense is to be covered by the candidate and the school running the candidate. This is a crucial training for National Officer Candidates to ensure their success.

*National Conference (Year 1) June TBD, 2024 – Running a quality campaign and ensuring the best representation of SkillsUSA Ohio, keeping in mind, and abiding by the Code of Conduct at all times. (Year 2) Under the direction of National Staff, represent Ohio to the best of their ability at the National Conference while staying in communication with SkillsUSA Ohio.

*Fall Conference November TBD, 2024 – Assist State Officers and Presenters – Select Officers will be assigned presentations for students and advisors.

*Regional Contests (February/March 2024)– Work with Regional Advisors assigned to their region to perform Awards Ceremony and assist with making the conference a success.

*State Championships (April 2024)- Assist State Staff/Advisors and Officers in providing a quality conference to SkillsUSA Ohio's membership.

If officers are evaluated to be of quality substance and merit, they may be asked to be an extension of the SkillsUSA Ohio State Officer Team.

Roles at all conferences and special invitations will be determined based on the assets, skills, and interests of each student; the goal is to ensure that all students get the most out of their officer experience while representing SkillsUSA Ohio to the best of their ability.

The National Officer Candidate Selection Process

The National Officer Candidate election will be at the State Delegate Assembly. Ohio will have a maximum of two National High School Officer Candidates. The office they are running for will be determined during the National Officer Candidate Orientation at the National Prep Conference in June. The two candidate positions are: Region III Vice President and National Officer-at-Large.

National Officer Candidate Qualifications

- 1. They must be a paid SkillsUSA member.
- 2. They must be enrolled in an approved Career-Technical program.
- 3. Career Essentials Foundations must be presented to Delegate Supervisor at the Delegate Assembly during the candidate orientation meeting.
- 4. They must have one full year remaining in a Career-Technical Education program.
- 5. Each CTPD may test as many students as they would like.
- 6. They cannot serve as High School Voting Delegates at the State Delegate Assembly.
- 7. They cannot compete in the state SkillsUSA Championships.
- 8. They must attend one non-school day of training (during State Officer's Retreat). Failure to attend may result in removal from the national ballot.
- 9. They must attend the Ohio National Prep Conference on Monday, June 7, 2024.

Procedure to run for national office

- I. The candidate must complete application.
- 2. An administrator must request screening test prior to March 15, 2024.
- 3. A school administrator must administer screening test, and:
 - Students can take the test one time only.
 - Test will consist of 25 multiple-choice questions from leadership general knowledge, the SkillsUSA Framework, the SkillsUSA Career Essentials and/or the Leadership Handbook.
 - The student must score 80% or better to be on the primary ballot and must present evidence of PDP/Career Essentials Experiences completion at screening interview on Tuesday of the State Conference.

- 4. The administrator must return cover sheet of the application packet to the SkillsUSA Ohio office prior to March 15, 2024. The complete packet must be submitted by March 15, 2024.
- 5. By March 15, 2024, the Administrator or Lead Advisor must contact SkillsUSA Ohio to schedule an appointment for National Officer Candidate's Interview. The interview must be completed by March 19, 2024, in order for the Candidate to be considered for the ballot. The interview may be completed in person or by phone.
- 6. The application packet will be reviewed, and the candidates will be interviewed by a screening committee. (The committee may consist of State Director, SkillsUSA Ohio Staff and/or members of the Ohio Department of Education.) This committee will Determine final eligibility of the Candidate to be placed on the ballot.
- 7. Candidates and their advisors **must** attend the national conference at their school's expense. See National Application for further details.
- 8. The candidate must attend the state conference delegate assembly, and:
 - a. Must be in Official SkillsUSA dress.
 - b. All Candidates will give speech of no more than 2 minutes in length.
 - c. All National Officer Candidates will appear on a primary ballot and will receive an impromptu question based around general leadership or SkillsUSA Knowledge.
 - d. The top 4 candidates will appear on the final ballot and will respond to a problematic oral question based on SkillsUSA knowledge and leadership
 - e. In between each ballot a 5-10 minute meet the candidate caucus session will occur.
 - f. Skits are not permitted.
 - g. Candidates may not use their own school names in their speech.
 - h. Candidates are not permitted to use other school names in their speech.
 - i. Candidates are not permitted to ask for audience participation during any response on stage.
 - j. Campaigning in any form or manner may not take place prior to the mandatory state officer candidate orientation meeting on Tuesday.
 - k. Campaign materials may only be displayed in designated Meet the Candidate area.
 - I. Materials that do not fit within the designated campaign space will not be permitted and are subject to disqualification (half of a 6 ft table). Materials must be a tabletop display. They may not be posted on the wall or stand independently in front of or behind the table.
 - m. National Officer Candidates may participate in a meet the candidate session prior to election.
 - n. Campaign materials must not consist of anything that can be consumed by a person.
 - o. Campaigning on social media prior to the meet the candidate session is not permitted.

Ties

- 1. A tie for second place on the primary ballot will result in the candidate with the most votes (first place) and both second place candidates being on the final ballot.
- 2. A tie on the final ballot will be broken by the results of the preliminary ballot. If still tied, another impromptu question will be asked by the SkillsUSA Ohio state director or designated person and the delegates will vote by secret ballot. This procedure will continue until the tie is broken.

The State and National Officer Candidate Screening Test

The State Officer Candidate Screening Test has been developed to ensure that candidates for State Office and for National Officer Candidates have taken some time to learn about SkillsUSA mission and program of work. It is important to the SkillsUSA Program that schools strictly adhere to the policies and procedures with regard to the selection of regional officer candidates. Elected officers will represent both the State Association and the local school on a national platform.

This test is administered at the local level so that schools may screen candidates prior to the SkillsUSA Ohio Championships. In order to maintain the integrity of this program we ask the Administrator or Advisor proctoring the test to strictly follow the guidelines below. Failure to do so may result in the disqualification of the candidate and or candidates from the school. The ability to proctor this test at the local level has been done as a cost-savings process for the local school to ensure the candidates they put up for office are serious.

Prior to testing:

- Candidates should be given a copy of the following:
 - State or National Officer Program Overview
 - Appropriate Application
 - Appropriate Study Resources
 - Date of when the testing will take place

Testing Process:

- ∧ This test is a pre-qualifier for students interested in running for Office.
- ∧ All testing should be proctored by an Administrator or Advisor
- Administrator or Advisor must request access on Screening Test Request form by March 15, 2024.
- ∧ Proctor will receive an emailed confirmation packet for Site Password.
- ∧ You may test as many students as you like.
- At the conclusion of the test, they will be given immediate feedback as to whether they have passed or failed.
- ∧ Any student who is a member of SkillsUSA may take the pre-qualification Test.
- ∧ Test should be given in a controlled setting under supervision of an advisor or administrator.
- A Students are only permitted to take the test once. Once they hit the submit button the results are final!!
- ∧ A passing score of 80% is required. The test is closed book.
- \wedge Students are to read the questions carefully and select the appropriate answer.
- \wedge Students are not able to return to the question after they have answered it.
- Honesty and Integrity are core values of SkillsUSA. Each student agrees to work independently of others taking the test. Students found cheating may be disqualified.
- Students who pass this test should consult their local advisor for other qualifications that must be met to seek the nomination for Regional Officer Candidate.
- While many students may take the pre-qualification test, each school may only nominate 7 candidates.
- ∧ Contact SkillsUSA Ohio at 614-604-6150 if you are having difficulty with the website.

After the Test

- \wedge Students will receive immediate feedback as to whether they have passed or not.
- \wedge Those students who have passed are now eligible to begin the application process.
- ∧ Each student should complete the application and obtain the appropriate signatures.
- A The school advisor/administrator should then review all applicants and through a structured process make a determination that they are eligible to run for Office.
- In this packet there are copies Letters to give to the student and Parents about the Officer Programs.
- Application Materials are due by March 15, 2024, in the SkillsUSA Ohio office. Only seven State Officer Candidates and two National Officer Candidates are permitted to run from any school.
